



# Terms and Conditions of Business: Godzilla Tracking Rig

## Definitions:

- A) Godzilla Tracking Rig (GTR): Nissan Skyline GTR Chassis Number: JN1GANR35U0130005
- B) The Hirer: Company or organisation who have agreed to the use of the Godzilla Tracking Rig (GTR)
- C) Estimate: Fees and agreement of use agreed with the Hirer prior to the production date

## 1 Engagement

1.1 Any participation in the use of GTR will constitute acceptance of this agreement. The Hirer agrees to the terms and conditions contained within this document. If you (The Hirer) do not agree to abide by these terms and conditions you must do so in writing before commencement of the agreement.

## 2 Travel to and from the production facility

2.1 The road traffic act will be adhered to at all times. Parking fines, speeding tickets and congestion charges are the responsibility of the driver of the GTR.

## 3 Upon arrival on set

3.1 The set is deemed as the "Call" location/ Production base. The road traffic act will apply at all times unless otherwise agreed by local authority / Police. Any exemptions must be given in writing and provided to Automotive Exposure Limited prior to use. They must also be noted in the production risk assessment.

3.2 The condition of the GTR will be acknowledged upon arrival by a member of production team (The Hirer). Any defects should be noted in writing prior to commencement of use.

3.3 The GTR and any associated equipment attached to the vehicle will become the full financial responsibility of the Hirer. This includes but is not limited to: Insurance, Fuel, Parking fines, speeding tickets, congestion charges, maintenance, excess wear and tear, cleanliness. Any third party equipment placed inside the GTR is the responsibility of Hirer.

3.4 By placing equipment on The GTR, you (The Hirer) acknowledge any risk and except liability for it.

3.5 The GTR will not be driven in a manor deemed dangerous or reckless. The Hirer acknowledges it will be driven at high speeds when requested and this will be noted in the production risk assessment.

3.6 The Hirer must acknowledge the high speeds that The GTR is capable of. It is the responsibility of The Hirer to ensure that all crew working in close proximity to GTR are made aware of the extra care needed due to the speed of the vehicle.

3.7 Only appropriately experienced drivers will drive the GTR. They must be identified by The Hirer on the production risk assessment before commencement of use.

3.8 The driver(s) of the GTR will not be liable for any damages caused whilst under the direction of the Director or Camera Operator.

3.9 Excessive wear and tear, including but not limited to, brake pads and tyres, will be chargeable to the The Hirer at an agreed fee. (Costs will be agreed with The Hirer before invoicing)

## 4 Limitations of use

4.1 Automotive Exposure Limited reserve the right to limit the amount of GTR use. Excess charges will apply if this is use is exceeded. (This will be agreed prior to further use of the GTR on the day(s) of use).

## 5 End of agreement

The GTR should be inspected by a member of the production team at the end of the agreement and the condition noted. Any defects caused during the use will be the responsibility of production and should be noted via Email or in writing on the day(s) of use. These defects will be the financial responsibility of The Hirer and any incurred costs invoiced on the final job invoice.

## 6 Privacy

## 7 Payment.

7.1 Payment is due no later than 30 days after the end of each engagement.

7.2 A 20% charge will be due if payment is later than 30 days from invoice date.
